P/S Dolly Leg going down on its own

CORRECTION:

OCT 24TH/25 S.S FOUND THE LEGS HEIGHT OFF AND THE CRANK EXTREMELY HARD TO MOVE. LOWERED THE LEGS TO THE GROUND AND BLOCKED UP THE ONE THAT DIDN'T TOUCH. REMOVED THE GEARS AND FOUND VERY LITTLE GREASE IN IT AND RUST STARTING IN THE BUSHINGS. PULLED THE TOP CAPS OFF THE LEG AND DIDN'T SEE ANYTHING UNUSUAL IN THERE. ONE LEG IS DIFFERENT THEN THE OTHER, DIFFERENT PADS ON THE BOTTOMS AND DIFFERENT LENGTHS. CLEANED THE CORROSION OUT OF THE GEAR BOX AND LUBED ALL THE BUSHINGS AND GEARS FOR ASSEMBLY. PUT BACK TOGETHER AND NOW CRANKS MUCH EASIER. SET THE HEIGHT OF THE LEGS TO THE SAME FROM THE GROUND AND RECONNECTED THEM. MONITOR THE LEGS TO SEE IF THEY KEEP TIME.
