-GO UNDER THE TRUCK AND CHECK OUT WHAT HAS TO BE DONE FOR MAKING AN EXHAUST BRACKET TO HOLD UP THE Y PIPE.

SEPT 30/2025 L.B-

-FOUND FUEL LEAK ON THE RETURN LINE COMING FROM THE BACK OF THE HEAD GOING TO THE FILTER HOUSING, -REMOVED LEFT FRONT FENDER SO I COULD GET TO IT EASIER, MADE CROWS FOOT TO REMOVE THE FITTING ON THE BACK OF THE HEAD, REMOVED OLD LINE MEASURED AND CUT NEW FUEL LINE, WRAPPED IN OMNI WRAP AND PUT FIELD ATTACH FITTINGS ON. INSTALLED NEW LINE ONTO UNIT, PRIMED FUEL AND TIGHTENED DOWN FITTINGS. TIED UP FUEL LINE WITH ZIP TIES. GOT DREW TO REMOVE BROKEN FLEX PIPE AND CUT NEW LENGTH.

OCT 1/2025 L.B- PRESSURED UP RAD WAS LEAKING TOWARD BOTTOM, RECOVERED AC AND REMOVED RAD, PUT AIR INTO RAD, FOUND CRACK ON THE PAN. GRABBED NEW EXHAUST CLAMPS FOR THE NEW FLEX PIPE AND INSTALLED ONTO UNIT. RE INSTALLED FRONT LEFT FENDER. RECHARGED A/C AND RE FILLED COOLANT RAN UNIT AND CHECKED FOR LEAKS.

R.K. OCT 1/25 MAKE UP AN EXHAUST BRACKET TO SUPPORT THE EXHAUST BY THE Y PIPE. STEEL USED 1 FOOT OF 2 INCH BY 1/4 INCH FLAT BAR. 6 INCHES OF 4 INCH BY 1/4 INCH ANGLE IRON. BOLT IN THE BRACKET AFTER BEING PAINTED BLACK.
