-CHECKED CRANKCASE AS PER KOHLER BULLETIN BY REMOVING HOSE THAT GOES FROM THE OIL MIST SEPARATOR TO THE INTAKE HOSE JUST AFTER THE AIR FILTER, VERY LITTLE AIR COMING FROM HOSE WHILE IDLING. CHECKED ON A LIKE UNIT, AND AIR PRESSURE WAS SIGNIFICANTLY MORE, WILL ORDER SEPARATOR FILTER.
