NOV 15/21 C.B, TOOK THE RIGHT REAR TAIL LIGHT HOUSING APART AND REMOVED THE TAIL LIGHT, REMOVED THE BULB AND INSTALLED A NEW LIGHT (1157) REINSTALLED THE HOUSING AND LIGHT.

NOV 15/21 C.B, CHECKED HYDRAULIC LEAKS ON UNIT #54-004, 13480 HRS.

BOTH BLADE LIFT CYLINDERS ARE LEAKING AND THE HYDRAULIC SWIVEL GOING TO THE BLADE IS LEAKING, REPLACED THE BULB IN THE TOP FRONT CAB LIGHT ON THE RIGHT SIDE, H7 BULB.
