COMPLAINT:

LIFT CYLINDERS ARE LEAKING AND NEED TO BE RESEALED

CORRECTION:

FEB 3/24 SB = FOUND SEALS IN THE SECAN AT FOSTER THAT CHASE HAD ORDERED, STARTED UNIT AND LIFTED THE ARMS UP TO INSTALL LOCKING ARM, INSTALLED LOCKING ARM, REMOVED TOP HOSE ON CYLINDER ON THE LEFT SIDE, HAD TO REACH IN FROM THE BACK AND CRACK THE BOTTOM LINE LOOSE, PULLED THE TOP PIN, REMOVED ROD, HAD TO SET UP THE OXY TORCH TO BUST THE NUT LOOSE ON THE BOTTOM OF THE ROD, REMOVED ALL PARTS FROM THE ROD AND INSTALLED NEW SEALS, NOTICE SOME GOOD MARKS ON THE PISTON ON THE BOTTOM, POLISHED THEM SO THEY WERENT RAISED, LOOKED IN THE BARREL OF THE CYLINDER ALL LOOKS GOOD, INSTALLED CYLINDER ROD, INSTALLED LINES, PUT PIN BACK IN, LIFTED UP BUCKET AND REMOVED LOCKING ARM, CYCLED HYDRAULICS UNIT AIR WAS GONE AND SET UP LOCKING ARM ON THE RIGHT SIDE OF MACHINE, REMOVED TOP PIN ON THE RIGHT SIDE CYLINDER, REMOVED HYD LINES, UNSCREW ROD CAP AND REMOVED ROD, CLEANED IT ALL UP AND CHANGED SEALS INSTALLED NEW NUTS INCLUDED WITH THE SEAL KIT, INSTALLED ROD BACK INTO CYLINDER, HOOKED UP LINES, REMOVED LOCKING BAR AND CYCLED HYDRAULICS A FEW TIMES, CHECKED HYD OIL LEVEL IT WAS STILL GOOD SINCE UNIT WAS OVERFULL, CLEANED UP WORK AREA , DROVE BACK TO SHOP,
